- We can't blame the tool!





User considerations

- Behavior complies with laws and regulations
 - Different depending on location and industry
- Treat everyone equally without discrimination
- Understand how the tool works
- Respect individual rights
- Protect business data
- Applies to prompts and outputs



Check the policy

- Code of conduct or policy
- How to use it
- Data expectations
- Follow these policies

Guidelines on:

- Financial data
- Personal data
- Proprietary data

Policies may differ!




General input considerations

- Personally identifiable information:
 - ID numbers
 - Addresses
 - Medical
 - Banking
- Proprietary information:
 - Confidential strategies
 - Legal
 - Financial



General input considerations



- Provider using the data
- Vulnerable to attacks

General output considerations

- Bias: unfairly favors one outcome
- Context tracking: losing track of the conversation
- Hallucination: confident incorrect answer


- Tool will have built-in safeguards



Incorrect outputs



Validation techniques

- Evaluate the output ourselves with domain knowledge
- Compare the results or ask an expert
- Use question-and-answering
- Always proofread



Validate ourselves

- Financial analyst:
 - Transfers a route calculation
 - Checks it with their own calculation



Comparing results

- Analyst writing a report:
 - Compare the results with a previous report
 - Compare with other company sources



Ask an expert

- People team manager:
 - Creating a week-long program
 - Connects with benefits manager
 - Connects with mental health specialist
 - Checks the plan is appropriate



Question-and-answering

- Stock manager:
 - Ask follow-up questions to verify the answer
 - "What was your methodology?"
 - "Show me the steps you took to get to this answer"
 - "Please correct this part"
